### TERMS AND CONDITIONS AND PRIVACY POLICY

#### INTRODUCTION

#### **GIVEAWAY TERMS AND CONDITIONS**

Please note that the **Giveaway** includes **only one ticket to** <u>Web Summit 2024</u>. It **does not** cover travel, accommodation, or any other personal expenses. The winner will be responsible for all such associated costs.

## PARTICIPATION ELIGIBILITY

To be able to participate in the Giveaway, participants must register on the **DeepTech ACT platform** between Monday, 23<sup>rd</sup> of September 8:00 AM (CET) and Monday, 30<sup>th</sup> of September 11:59 PM (CET) and are required to accept and agree to these Terms and Conditions and Privacy Policy, as well as the Privacy Policy of the DeepTech ACT platform by ticking the appropriate boxes during the registration process.

By agreeing, you affirm that:

- You are at least **18 years** old at the time of participation.
- You are a legal **resident** of one of the 27 member countries of the **European Union**.
- You are not an employee of the Giveaway Organiser, nor are you an immediate family member of an employee of the Organiser.

#### WINNER SELECTION PROCESS

The Giveaway Organiser will follow these steps for the winner selection:

- The Giveaway Organiser will collect the contact details of participants (name, surname, email, and country of residence) and be record them in an Excel spreadsheet.
- Each participant will receive a unique identification code.
- The 'Random' function in Excel will be used to select the winner.
- The selected participant's eligibility will be verified.
- If the selected participant is eligible, the process will conclude. If not, the process will repeat until a valid winner is found.
- The winner will be contacted via email or phone to confirm the acceptance of the prize.
- After the first contact by the Organiser, the winner has **five working days to reply by e-mail or phone communicating the acceptance or rejection of the prize.**
- If the winner doesn't respond or declines, the process will be repeated to select another eligible participant.

The announcement of the winner's identity will be made through AccelerAction's social media channels, specifically LinkedIn and Twitter, **only with the winner's explicit consent**. To grant this consent, the winner must complete and sign the <u>AccelerAction consent form for Image/Audio/Presentation</u>. This form ensures that the winner agrees to the use of their identity and any associated imagery or audio in connection with the prize.

## PRIVACY POLICY

For the Giveaway selection process, the personal information of participants will be handled as follows:

- The Giveaway Organiser will collect specific contact details, including full **name**, **surname**, **email address**, **and country of residence**.
